In our material event disclosure dated 21.05.2012; With the letter of the Competition Authority dated 09.05.2012-2272; "It was decided to open an investigation against our company with the decision of the Competition Board dated 24.04.2012 and numbered 12-21/560-158 to determine whether it has violated Article 4 of the Law No. 4054 on the Protection of Competition, and in our material event disclosure dated 10.07.2013; With the Competition Board Decision dated 08.07.2013 and numbered as 13-42/538-238, it has been stated that "As a result of the investigation to determine whether the undertakings operating in the field of waste paper recycling have violated Article 4 of the Law No. 4054 by acting together regarding the issuance of the necessary document for export to the undertakings wishing to export waste paper, it has been decided that 7 companies, including our company, have violated Article 4 of the Law No. 4054 on the Protection of Competition by acting together regarding the issuance of the necessary document for export to the undertakings wishing to export waste paper. However, it was previously announced to the public that "it was decided to grant individual exemption to the said practice for three years as of June 2011, when the aforementioned Communiqué started to be implemented, provided that objective criteria are determined, and to assign the Presidency to determine the objective criteria".

As a result of the lawsuit process carried out for the annulment of the aforementioned Board decision, it was decided to annul the Competition Board's decision dated 08.07.2013 and numbered 13-42/538-238 with the decision numbered 2024/294 Esas and 2024/386 of Ankara 14th Administrative Court.

With the announcement made by the Competition Board, it has been announced to the public that in order to fulfill the requirements of the relevant court decision, it has been decided to open an investigation with the decision numbered 24-14/284-M against the organizations including our company.

The English translation of this statement is attached hereto, and in case of any discrepancy in the texts of the statement, the Turkish statement will be taken as the basis.

We proclaim that our above disclosure is in conformity with the principles set down in "Material Events Communiqué" of Capital Markets Board, and it fully reflects all information coming to our knowledge on the subject matter thereof, and it is in conformity with our books, records and

documents, and all reasonable efforts have been shown by our Company in order to obtain all information fully and accurately about the subject matter thereof, and we're personally liable for the disclosures.
